SUBJECT: REQUEST AUTHORIZATION TO ACCEPT TWO GRANT AWARDS FROM THE CORPORATION FOR PUBLIC BROADCASTING (CPB) FOR FUNDING UNDER THE COMMUNITY SERVICE GRANT PROGRAM

COMMITTEE: INSTRUCTIONAL EXCELLENCE AND COMMUNITY ENGAGEMENT

Authorization is requested to accept two grant awards from the Corporation for Public Broadcasting (CPB) in the amount of \$1,631,040, to partially support day-to-day operations of WLRN-TV and WLRN-FM for the grant period of October 1, 2006, through September 30, 2008, as follows:

Program	Grant Amount
Television Community Service Program	\$1,269,336
Radio Community Service Program	\$ 361,704
Total	\$1,631,040

In 1967, Congress passed the Public Broadcasting Act which established the CPB. The CPB is a private, nonprofit organization that funds over 1,000 public television and radio stations nationwide using an annual appropriation from Congress. Allocations to public broadcasting stations are computed based upon a formula which uses a station's non-federal financial support. These grants will be managed by WLRN and support the Superintendent's initiative to actively engage family and community members.

No matching funds are required as a condition to receive the grant funding. Grant funds will be used to partially support personnel, operations, and programming of WLRN-TV and WLRN-FM. Indirect cost is not allowed.

The Radio Community Service Program for WLRN-FM also stipulates that approximately 27.85%, or \$100,735, of the grant funding must be used to pay a portion of the costs of WLRN-FM programming that is provided by National Public Radio or Public Radio International, including programs such as *Morning Edition*, *Talk of the Nation*, *All Things Considered*, *News & Notes*, *Car Talk*, *Weekend Edition*, *A Prairie Home Companion*, *Marketplace*, and *This American Life*.

Official notifications of these grant awards were received on or September 25, 2006. Reimbursement of grant-related expenditures is authorized effective October 1, 2006.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept two grant awards from the Corporation for Public Broadcasting (CPB) for funding under the:
 - a. Television Community Service Program in the amount of \$1,269,336; for the grant period of October 1, 2006, through September 30, 2008; and
 - b. Radio Community Service Program in the amount of \$361,704; for the grant period of October 1, 2006, through September 30, 2008;
2. extend these programs as authorized through official notification from the granting agency in order to complete the goals of the programs; and
3. direct Financial Operations to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board.
