**SUBJECT: RECLASSIFICATION OF MANAGERIAL EXEMPT PERSONNEL (MEP) POSITIONS AND PROFESSIONAL AND TECHNICAL POSITIONS IN DADE COUNTY SCHOOLS ADMINISTRATORS' ASSOCIATION (DCSAA)**

- 1. APPROVE THE RECLASSIFICATIONS, TITLE CHANGES, AND/OR UPDATES TO JOB DESCRIPTIONS WHICH MAY INCLUDE CHANGES IN MINIMUM QUALIFICATIONS OF SELECTED MANAGERIAL EXEMPT PERSONNEL (MEP) AND PROFESSIONAL AND TECHNICAL (DCSAA) POSITIONS**
- 2. ESTABLISH AND CLASSIFY NEW JOB DESCRIPTIONS FOR EXISTING MANAGERIAL EXEMPT PERSONNEL (MEP) AND PROFESSIONAL AND TECHNICAL (DCSAA) POSITIONS**

**COMMITTEE: SCHOOL SUPPORT ACCOUNTABILITY**

Reclassification of a position to a higher pay grade may result from redistribution of work assignments which significantly increase the duties and responsibilities of a position. In addition, some job descriptions necessitate an update to reflect state requirements, technical skill requirements, and/or organizational needs pursuant to the 2005-2008 District Strategic Plan. Job reclassification recommendations for Managerial Exempt Personnel (MEP) and Professional and Technical employees represented by the Dade County Schools Administrators' Association (DCSAA) are submitted to the School Board for approval on a regular basis in order to meet the on-going organizational needs of M-DCPS. The 2005 job reclassification recommendations were approved at the July 13, 2005 School Board meeting. Provisions of the Manual of Procedures for MEP, Section A-7, define the job reclassification review process in which reclassification requests are initiated by the appropriate member of the Superintendent's Executive Staff. Provisions of the M-DCPS/DCSAA labor contract, Article XIII, Section 6, also delineate the job reclassification review process in which reclassification requests may be initiated by the employee or immediate supervisor.

These reclassification requests for the MEP and DCSAA positions were submitted for review during the 2006 annual review process. These reclassifications are primarily in the following major areas:

## **Facilities Operations**

Over the past two years, the volume of new construction and renovation awards in Facilities has increased dramatically. The employees affected have assumed additional responsibilities due to the high volume of work activity.

## **Information Technology Services (ITS)**

Information Technology Services' workload has increased based on the 5-year technology plan. There have been over 20 new system applications integrated into the current systems. Also, ITS has gained additional users, i.e., parents, teachers. The ITS department is transitioning due to changes in technology. This translates into changes in the skill sets needed for programming, training and support staff as the reliance on new computing environments becomes critical to the success of the operation. Further, there are changes roles and responsibilities to assist with providing the best in class service to schools sites and non-school sites served; to manage the change management process resulting from of the introduction of new technology; and to better align the skill sets with the market place where there is competition for talent. In addition, several of these reclassifications are in accordance with the technical career path contract provisions in the DCSAA labor contract.

## **Transportation**

The positions in Transportation have not been reviewed for reclassification since 1990. Since that time there has been a tremendous increase in the accountability and the span of control of these positions resulting from a reduction in administrative staff. In addition, there has been a plethora of additional federal, state, local and union requirements that must be adhered to and monitored on an on-going basis, i.e., "S" endorsement license for school bus drivers, mandated drug and alcohol testing programs, Omnibus Transportation Employee Testing Act (OTETA) for major school bus accidents/incidents, etc. The average transportation center now employs over 500 employees, operates on a 14-hour day schedule and is responsible for transporting approximately 25,000 students daily. Further, there are major challenges each day, i.e., such as providing transportation for students with special needs, constant changes in routes due to construction or the addition of new students, and managing the work force of bus driver to ensure students are picked up and delivered to school on time.

## **Finance**

The majority of positions in Finance have not been reviewed in seven or more years. Since that time, there has been an introduction of new services added in Finance i.e., Request for Proposals (RFP) for Professional Services, Shopping Cart for Procurement, Purchasing Card, etc. Further work processes have been redesigned to align with best practices in the industry and to meet the initiatives of the District Strategic Plan.

The reclassification requests were reviewed by Compensation Administration and the appropriate cabinet member. Compensation Administration is responsible for submitting the findings with advisory recommendations to the Assistant Superintendent, Labor Relations.

These findings are based on a variety of job analysis techniques including job description reviews, supervisory interviews, surveys of the job markets for which the organization competes for talent, and/or reviews of internal pay relationships. In some cases, on-site job audits and salary comparisons were also conducted. There were 50 positions submitted for reclassification. Thirty-nine (39) positions are recommended for reclassification, changes in minimum qualifications, and/or new job descriptions to appropriately reflect duties and responsibilities of current existing positions. No change is recommended for the eleven (11) remaining positions which are currently classified appropriately. Total cost of the reclassification to the General Fund is approximately \$182,500. The total number of employees affected is 110 of which 42 employees are abated to capital funds, and 22 employees are funded through a reduction of full-time positions in Information Technology Services (ITS). } Revised
