SUBJECT: BALANCE AWARD BID NO. 058-FF03 – CAFETERIA SERVING SUPPLIES

COMMITTEE: INNOVATION, EFFICIENCY & GOVERNMENTAL RELATIONS

The purpose of this bid, opened on April 6, 2006, is to purchase and deliver, at a firm unit price, quantities, as may be required, of cafeteria serving supplies, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. This bid awards two delivery options: Truckload, which is delivered to the District's central warehouse, and LTL (Less than Truck Load), delivered to each individual school location. Eighteen (18) vendors responded to this advertised solicitation.

Items G10 through G15, G25 through G31, G59, G65 through G69, G70 through G72, G76 and G77 were awarded by the Board on June 14, 2006, for an estimated expenditure amount of \$9,799,641.20.

Items G1 through G9, and G44 through G51 were awarded by the Board on September 13, 2006, for an estimated expenditure amount of \$1,728,721.14.
