SUBJECT: SCHEDULE OF SCHOOL BOARD MEETINGS FOR 2007

Section 1001.371, Florida Statutes, requires that the Board establish dates for its regular meetings at the organization meeting each year.

The 2007 Board meeting schedule was tentatively approved by the Board at its July 12, 2006 meeting. At this time, Miami-Dade Days in Tallahassee had not yet been scheduled. On November 6, 2006, the District received notification that this event is scheduled for Tuesday, April 17, and Wednesday, April 18, 2007.

Wednesday, April 18, 2007 was tentatively established as a regular School Board meeting date as well as the public hearing on Attendance Boundaries. In light of the Miami-Dade Days schedule, the Board may wish to consider other options for its April 2007 meetings.

Listed below are the dates recommended for regular Board meetings, special Board meetings, and Board conference sessions during 2007.
