**COMMITTEE: SCHOOL SUPPORT ACCOUNTABILITY**

Section 1001.42(4)(f), Florida Statute, regarding the responsibility of district school boards to set school start dates was amended this past legislative session, May, 2006, mandating that school boards shall, "Adopt policies for the opening and closing of schools and fix uniform dates; however, beginning with the 2007-2008 school year, the opening date for schools in the district may not be earlier than 14 days before Labor Day each year." Additionally, School Board Rule 6Gx13- 6A-1.01, School Calendar, requires that the school calendar provide more than the minimum days required by law to include days scheduled for inservice staff study sessions, for emergency school closings due to storms or other extreme events, and that it be adopted by the School Board annually. In order to comply with Section 1001.42(4)(f), F. S., Board Rule 6Gx13- 6A-1.01, School Calendar, and to allow the Superintendent of Schools the flexibility to make adjustments to school calendars in a timely manner should it become necessary under emergency situations, the school calendars proposed for the 2007-2008 school year have been developed by the School Calendar Ad Hoc Committee representing Miami-Dade County Public Schools and the United Teacher of Dade, and are submitted, not as a Board rule, for approval in Agenda Item D-48 at the January 17, 2007, School Board meeting.

This item is submitted for consideration by The School Board of Miami-Dade County, Florida, to repeal School Board Rules 6Gx13- 6A-1.02, Elementary and Secondary School Calendar 2006-2007; 6Gx13- 6A-1.021, Edison Schools, Inc. – Henry E. S. Reeves Elementary School Calendar – 2004-2005; 6Gx13- 6A-1.022, Extended School Year Calendar - 2002-2003; 6Gx13- 6A-1.023, Juvenile Justice Education Extended School Year Calendar – 2006-2007; 6Gx13- 6A-1.024, School Improvement Zone School Calendar – 2006-2007; and 6Gx13- 6C-1.02, Adult/Vocational Education School Calendar – 2006-2007.

Attached are the Notices of Intended Action and the School Board Rules proposed for repeal.

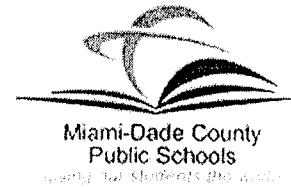
