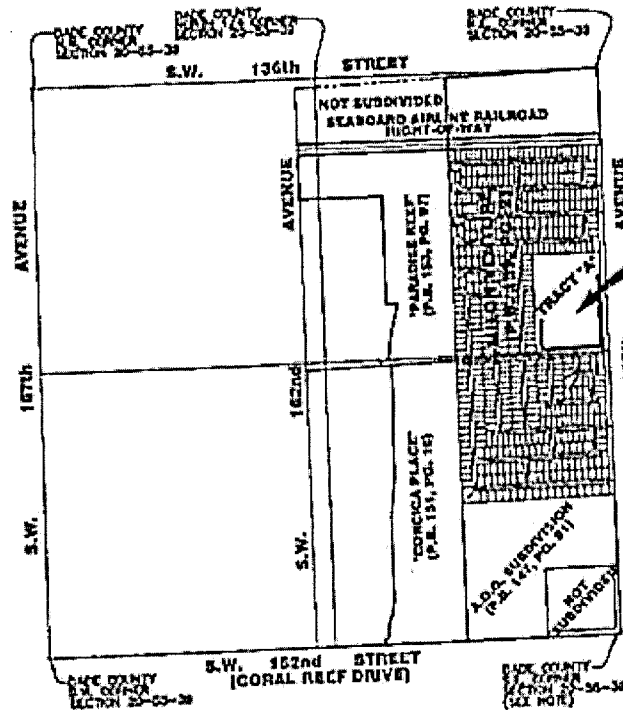
In order to maintain a water line easement constructed to provide adequate fire protection and water services to the Jorge Mas Canosa Middle School site, Miami-Dade County has requested that a 12-foot wide water line easement be granted by the district.

The 12-foot wide water line easement described will cover the area of the water line installations at the 13.5-acre school site. This area is legally described in Exhibit "A", attached hereto.

The Grant of Easement will be reviewed and approved by the School Board's Attorneys Office prior to execution. In addition, the proposed easement has been reviewed and recommended by the Office of School Facilities. Public utility facilities constructed on Board-owned property will be conveyed, with appropriate easements, to Miami-Dade County for future maintenance and operations.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the execution of the water line easement at the Jorge Mas Canosa Middle School site. Project No. A01019, in favor of Miami-Dade County.

Commence at the Northeast corner of said Tract A; thence S02deg29min02secE, along the East line of the said Tract A, for a distance of 231.79 feet to the POINT OF BEGINNING a 12.00 feet wide Water main Easement, lying 6.00 feet on each side of the following described centerline(shortening or extending the side lines so as to create a continuous strip of land); thence S87deg30min58secW, for a distance of 24.50 feet; thence S02deg29min02secE for a distance of 17.71 feet to Reference Point "A"; thence continue S02deg29min02secE, for a distance of 298.15 feet to Reference Point "B"; thence continue S02deg29min02secE, for a distance of 291.24 feet to Reference Point "C"; thence continue S02deg29min02secE, for a distance of 72.50 feet; thence S86deg21min57secW for a distance of 490.60 feet to Reference Point "D"; thence S87deg41min14secW, for a distance of 34.72 feet to Reference Point "E"; thence continue S87deg41min14secW, for a distance of 22.44 feet; thence N02deg18min53secW for a distance of 267.96 feet to Reference Point "F"; thence continue N02deg18min53secW, for a distance of 16.34 feet to the POINT OF TERMINATION of the aforementioned centerline.

Commence at the aforementioned Point "D"; thence S03deg38min03secE for a distance of 6.00 feet to the POINT OF BEGINNING a 12.00 feet wide Water Main Easement, lying 6.00 feet on each side of the following described centerline (shortening or extending the sides lines so as to create a continuous strip of land); thence continue S03deg38min03secE for a distance of 10.00 feet to the POINT OF TERMINATION, of the aforementioned centerline. The side lines of said easement to be shortened or prolonged to meet at angle with the southerly line of said Tract "A".

TOGETHER WITH:

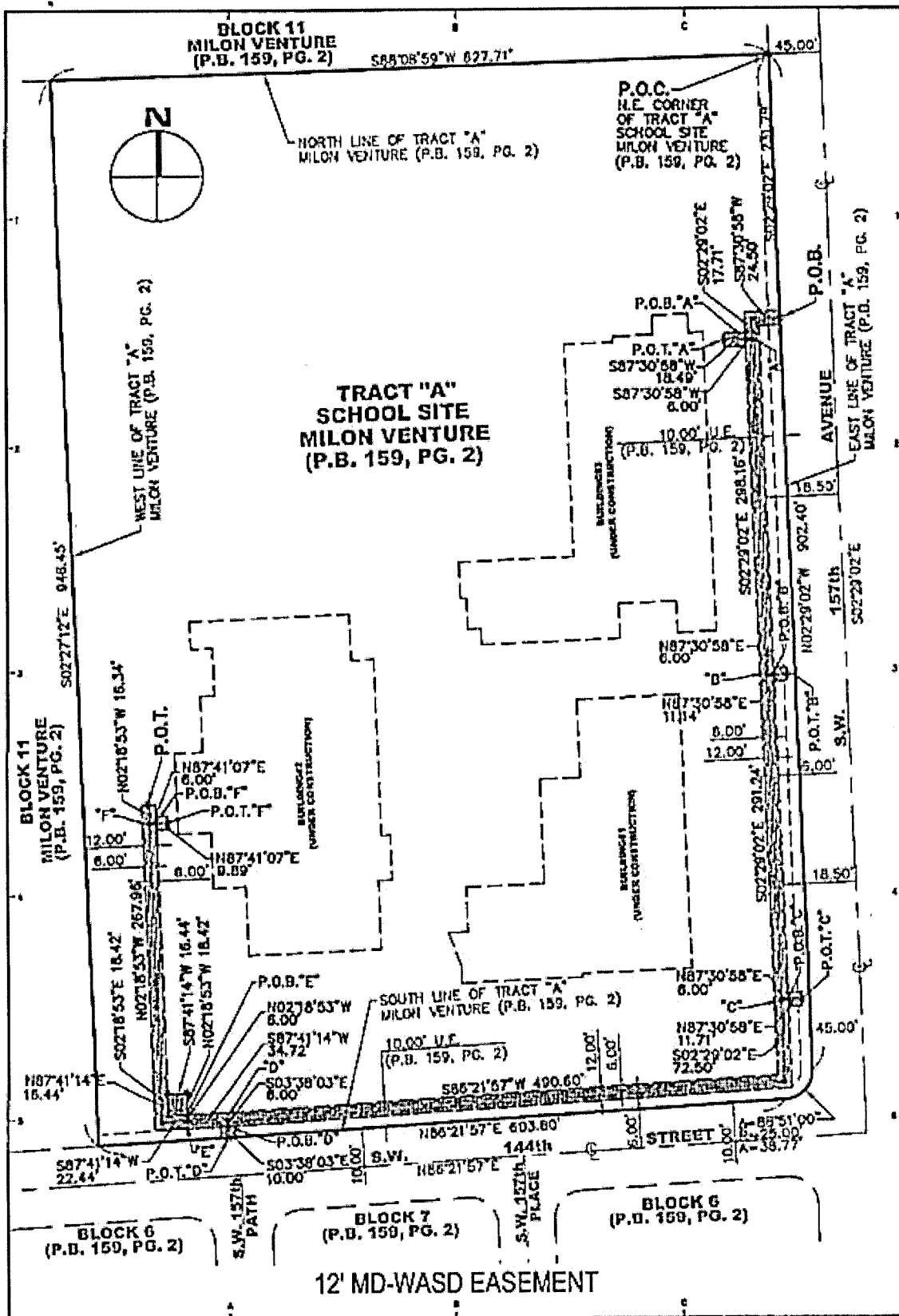
