The purpose of this bid, opened on March 15, 2007, is to purchase, at a firm unit price, quantities, as may be required, of petroleum products, oil, lubes, greases and derivatives, for the Department of Transportation, Vehicle Maintenance. Six (6) vendors responded to this advertised solicitation.

No bids meeting specifications were received for Items 4A, 4B and 12. The recommendation reflects that these items be rejected. Competitive prices will be solicited for these items as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Benchmarking of several items was conducted against the Pompano Beach Cooperative Bid H-36-05, which includes Broward County, and the District's prices were found to be lower.
