AGREEMENT WITH THE FLORIDA DEPARTMENT OF HEALTH, MIAMI-DADE COUNTY HEALTH DEPARTMENT, AND ACCEPT \$76,000 TO SUPPLEMENT FUNDING FOR HEARING SCREENING SERVICES EFFECTIVE AUGUST 1, 2007 THROUGH JUNE 30, 2008

Florida School Health Services Administrative Rule 10D-84.16 and School Board Rule 6Gx13- 5D-1.021, School Health Services Program, mandates that school districts conduct hearing screening of students in grades kindergarten, one, two, three, six, and 10, and for students entering Florida schools for the first time in grades kindergarten through five.

This request is to enter into a contractual agreement with the Florida Department of Health, Miami-Dade County Health Department to supplement funding for hearing screening services. Through a contract, the Miami-Dade County Health Department will disburse \$76,000 to supplement Miami-Dade County Public Schools total hearing screening cost of \$327,433.34 in order to screen over 100,000 students for school year 2007-2008. This contract will be effective August 1, 2007 through June 30, 2008. The District has been contracting for the same hearing supplement with the Miami-Dade Count Health Department since 1996.

The Contract Manager for the Miami-Dade County Health Department is Ms. Amy Tejirian.
