The purpose of this bid, opened on June 5, 2007, is to establish a contract, to provide healthy snack vending machines, for Miami-Dade County Public Schools Department of Food and Nutrition. This is a term bid, providing for fixed monthly revenue per machine, for vending machines placed in vocational/senior high and middle schools, and teachers' lounges at the elementary schools. The total estimated annual revenue will be \$1,162,908. Nine (9) vendors responded to this advertised solicitation. This bid solicitation complies with the District's wellness and no trans-fat policy.
