On August 2, 2006, The School Board of Miami-Dade County, Florida, entered into an Articulation Agreement Between The Florida International University (FIU) Board of Trustees and The School Board of Miami-Dade County, Florida, for the Support of Dual Enrollment Programs and a District Interinstitutional Articulation Agreement Between The School Board of Miami-Dade County, Florida, and Miami Dade College (MDC), to make available courses that offer both high school and college credit for eligible students.

As part of the Revamping Education for Gifted and ALL Learners (REGAL) Plan efforts to provide greater opportunities for students to participate in advanced level courses, the University of Florida has submitted a new articulation agreement for implementation between Miami-Dade County Public School (M-DCPS) and the University of Florida for Dual Credit Enrollment that allows M-DCPS students the opportunity to take DE courses at the University.

Section 1007.235 of the Florida Statutes requires that superintendents of school districts and presidents of state universities that serve the school districts develop and implement a comprehensive articulation agreement for students enrolled in their respective school district and service areas.

Dual Enrollment (DE) is an academic acceleration mechanism in which eligible senior high school students can register for university classes with the opportunity to receive high school and university credit concurrently. Districts weigh Dual Enrollment (DE) courses the same as Advanced Placement (AP), International Baccalaureate (IB), and Advanced International Certification of Education courses. The state pays for the The District generates FTE funding for its DE students which is used to pay for DE textbooks. Students are responsible for their own transportation.

Mr. William Beesting, Assistant Dean, Office of Undergraduate Studies, oversees the articulation process at Florida International University, Ms. Rosario S. Roman, District Director, School & College Relations, oversees the articulation process at Miami Dade College, and Mary Jo Koroly, Ph.D., Board of Regents, Center for Precollegiate Education and Training, oversees the articulation process at the University of Florida.

Copies of the Articulation Agreements with FIU, the District Interinstitutional Articulation Agreement with MDC, and the University of Florida for Dual Credit Enrollment will be transmitted to School Board Members under separate cover and are available for inspection by the public in the Office of Board Recording Secretary, Room 924, and the Citizen Information Center, Room 158, 1450 NE Second Avenue, Miami, Florida 33132.
