**SUBJECT: AWARD BID NO. 089-GG07 – SCHOOL-BUS ROUTES FOR
APPROVED PRIVATE SCHOOL-BUS COMPANIES**

The purpose of this bid, opened on July 3, 2007, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of school bus routes, for the Department of Transportation. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Twenty one (21) vendors responded to this advertised solicitation.

The bid is structured to allow the award to each low bidder, per item, who has a sufficient number of buses and drivers required to provide the transportation services for the routes identified by the District. Inasmuch as a vendor may have been awarded several routes which resulted in the utilization of all its resources, the award of additional routes is not possible. Consequently, the award is made to the next low bidder with available resources and equipment. The low bidders for the following items have been awarded the maximum number of routes allowed for their resources; therefore, their low bids could not be awarded for these items:

- a. Carlos and Susana School Bus Service Corp. – Items 10 through 16, 19, 24 and 25.
- b. Air B School Bus Transportation, Inc. – Items 8, 10 through 16, 19, 24 and 25.
- c. Manolin & Pilar Martinez, Inc. – Items 13 through 16.
- d. Del Aguila Bus Service, Inc. – Item 13.
- e. Jomarron, Mayra School Bus Service – Items 26 through 34, 37, 41 and 42.
- f. Maria Gamboa Bus Service, Inc. – Items 49 and 53.
