This item is submitted for consideration by the Board to amend School Board Rule 6Gx13- 5D-1.08, Maintenance of Appropriate Student Behavior. This proposed amendment will streamline the rule and delete references to other School Board rules which may create potential conflicts pertaining to outdated language. In addition, consideration is requested to repeal the documents, **Code of Student Conduct Elementary** and **Code of Student Conduct Secondary**, currently under School Board rule 6Gx13- 5D-1.08, in order to promulgate a new document under a new rule.

The proposed new School Board Rule 6Gx13- 5D-1.081, Standards of Student Behavior, will provide a positive and more strategic focus for model students. Model students emulate core values as delineated in the new Codes of Student Conduct. The new **Code of Student Conduct Elementary** and **Code of Student Conduct Secondary** will be incorporated in this newly promulgated rule and made a part thereof. These new documents will serve to:

- set new standards for model student behavior;
- align Standards of Behavior for Model Students to the M-DCPS Core Values;
- focus on re-culturing schools by instituting systemic positive feedback to students utilizing the *SPOT* **success** system;
- incorporate lessons to be used as a teaching tool;
- provide resolutions for undesirable behaviors;
- reflect actions of the Florida Legislature; and
- clarify language.

Attached are the Notice of Intended Action, the rule proposed for amendment and the proposed new rule. Changes from the current rule are indicated by underscoring words to be added and ~~striking through~~ words to be deleted.

Copies of the proposed repealed documents, **Code of Student Conduct Elementary** and the **Code of Student Conduct Secondary**, which are incorporated by reference and are a part of School Board rule 6Gx13- 5D-1.08, and the new documents, **Code of Student Conduct Elementary** and the **Code of Student Conduct Secondary**, to be incorporated by reference and made part of the new rule, will be forwarded to the School Board Members under separate cover and will be available for inspection by the public in the Office of Board Recording Secretary, Room 924, and the Citizen Information Center, Room 158, 1450 N.E. Second Avenue, Miami, Florida 33132.

Authorization of the Board is requested for the Superintendent to initiate rulemaking proceedings in accordance with the Administrative Procedure Act for the amendment of School Board Rule 6Gx13- 5D-1.08, Maintenance of Appropriate Student Behavior and promulgation of new School Board Rule 6Gx13- 5D-1.081, Standards for Student Conduct.

**RECOMMENDED:**

That The School Board of Miami-Dade County, Florida, authorize the Superintendent to initiate rulemaking proceedings in accordance with the Administrative Procedure Act to:

1. amend School Board Rule 6Gx13- 5D-1.08, Maintenance of Appropriate Student Behavior;
2. repeal the **Code of Student Conduct Elementary** and **Code of Student Conduct Secondary**, which are incorporated by reference and are a part of this rule; and
3. promulgate new School Board Rule 6Gx13- 5D-1.081, Standards for Student Conduct, and the documents **Code of Student Conduct Elementary** and **Code of Student Conduct Secondary** which will be incorporated by reference and made part of this rule.

**Welfare****MAINTENANCE OF APPROPRIATE STUDENT BEHAVIOR**

The schools are established for the benefit of all students. The educational purposes of the schools are accomplished best in a climate of student behavior that is socially acceptable and conducive to the learning and teaching process. Student behavior that disrupts this process or that infringes upon the rights of other individuals will not be tolerated. The School Board endorses a zero tolerance policy toward school related violent crime.

The School Board reaffirms its support of the administrative staff and teachers in taking all necessary steps to enforce and implement all School Board rules pertaining to the maintenance of appropriate student behavior. Important among these rules are those in the areas of conduct, corporal punishment, suspensions and expulsions, and climate for learning.

~~The School Board directs that:~~

- ~~1. The Superintendent of Schools, through the Miami Dade Schools Police Department shall pursue the investigation and assist in the subsequent prosecution of any adults inciting students to perform violent and unlawful acts in the schools; and~~
- ~~2. Each individual teacher shall be granted full disciplinary authority over every student in his/her classroom, in accordance with Florida Statutes, Florida Board of Education rules, School Board rules, and administrative memoranda.~~
