The purpose of this bid, opened on April 10, 2007, is to purchase and deliver, at firm unit prices, quantities, as may be required, of cafeteria refrigeration and warming equipment, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Six (6) vendors responded to this advertised solicitation.

Items 13 through 24, and 30 are under product evaluation and will be awarded at a future Board meeting.

Benchmarking was completed against the District's last contract, and Palm Beach and Broward County School Districts, however, since there were differences in the bid specifications, a price comparison could not be performed.
