Under the Adult Education and Family Literacy Act, the Florida Department of Education (FLDOE) has awarded Miami-Dade County Public Schools (M-DCPS), grant awards. School Operations will oversee implementation of these performance-based programs. The grants support projects that demonstrate effective practices and increased academic achievement as a result of research-based practices in adult education, workforce readiness, and family literacy. Each grant award targets a special needs population such as incarcerated youth, non-native English speakers, migrants, adult learners, and parents of school-aged children.

At the School Board meeting of October 17, 2007, Agenda Item C-82 (Request Authorization To Accept Two Grant Awards From The Florida Department Of Education (FLDOE) For Funding Under The Adult Education And Family Literacy Act) will be presented. Once approved by the Board, Agenda Item C-82 will allow for the acceptance of these grant awards in the total amount of \$3,200,000, to fund the Adult Education and Family Literacy Programs, from July 1, 2007, through June 30, 2008.

Under these initiatives, the FLDOE requires the District to form collaborative partnerships with community partners and provide a variety of services to meet the special needs of the learners. These community-based organizations (CBOs) have met and exceeded performance deliverables as required by the grant application.

Under separate contractual agreements, community-based organizations will provide services as follows: ASPIRA of Florida, Inc., Mr. Raul Martinez, President & CEO, will provide literacy programs for Hispanic students in grades K-8 and their families; Coalition of Florida Farmworkers Organization, Inc., Mr. Arturo Lopez, Executive Director, will provide homeless assistance for migrant workers in Florida City and Homestead, Fanm Ayisyen Nan Miyami, Inc., Ms. Marleine Bastien, Executive Director, will provide homeless assistance and immigration services for the Haitian community; TROY Academy, Inc., Ms. Diane Payne, Executive Director, will provide special assistance to at-risk, adults and youth in the judicial system; Miami Beach Police Athletic League, Ofc. Harry Morgan, Executive Director, provide supplemental educational and recreational services to at-risk youth; Read 2 Succeed, Mr. David Castrillon, Executive Director, will provide a learning partnership in the community through reading and writing activities for adult learners and their families; Transition, Inc., Ms. Virama Oller, Executive Director, provide job-training and placement for exoffenders; Latin American Foundation, Inc., Mr. Francisco Urraca, Executive Director, provide educational training, outreach and family literacy services to the community: AGAPE Family Ministry, Mr. Claudio Perez, Executive Director, will provide adult literacy services; Family Life Center, Ms, Esperanza Martinez, Executive Director, will provide adult literacy services to their community; and KidWorks USA, Inc., Mr. William de la Sierra, President, provide supplemental educational services to students in grades K-6 and their families.

All collaborative partners were included as part of the grant proposal. The community-based organizations will enter into their contractual agreements with M-DCPS and payment will be rendered in several parts. The community-based organizations will receive fifty percent of their contracted amount during the first part of their contract and the remainder to be dispersed upon completion of the performance core measures and their contractual obligations.

In accordance with the terms of the grant applications, authorization is requested to enter into separate contractual agreements with the following community-based organizations for the total amount of \$220,000:
