The purpose of this bid, opened on May 29, 2007, is to purchase, at firm unit prices, quantities, as may be required, of classroom furniture, for various locations. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Ten (10) vendors responded to this advertised solicitation.

Items 4 through 6A, 13 and 13A were awarded at the September 5, 2007, Board meeting. Items 7 through 8A, and 9 through 10A, are being held for further evaluation and will be awarded at a future Board meeting.

Benchmarking was completed against The School Board of Broward County, Florida, and the District's prices were found to be lower.
