**SUBJECT: RESCIND AWARD TO YOHAY VENDING OF ITEMS 13 THROUGH 16, AND 18, AND CORRECT ALTERNATE AWARDEE ON ITEM 8 ON CONTRACT NO. 038-GG03 – HEALTHY-SNACK VENDING PROGRAM**

This contract was awarded by the Board on July 11, 2007 (Agenda Item E-146), to provide healthy-snack vending machines, for the Department of Food and Nutrition. This is a term bid, providing for fixed monthly revenue per machine, for vending machines placed in vocational/senior high and middle schools, and teachers' lounges at the elementary schools. The award was made to a primary and alternate vendor.

Subsequent to contract award, Yohay Vending Corporation, the primary vendor, withdrew its award acceptance of Items 13 through 16, and 18. The vendor elected, by letter, on file, to lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 – Performance and Payment Security, Declining a Bid Award, and Bonding Company Qualifications. The services are being provided by the alternate vendor.

Additionally, Board Agenda Item E-146 incorrectly reflected the award of Item 8 - Total Group M-2, Middle Schools, Region 2, to Bettoli Trading Corporation, as the alternate vendor. This item corrects the award of Item 8 to Lord's Mine, Inc., as the alternate vendor, at \$120.25 per machine, per month.
