1. CALL TO ORDER

The initial meeting of the Blue Ribbon Committee on Workforce Housing convened in conference Room 726 of the School Board Administration Building. The meeting was called to order at 2:05 p.m. by Ms. Ofelia San Pedro, Deputy Superintendent. The meeting commenced with the introduction of committee members.

2. REVIEW OF BOARD RESOLUTIONS AND TASK FORCE MISSION

Ms. Greer provided the committee with an overview of work previously performed by the Task Force on Affordable Housing and Compensation Trust and the School Board, as indicated in documents provided to the Committee. Ms. Greer informed committee members that the initiative of this effort is to provide our teachers with an avenue to facilitate the purchase of workforce housing, thereby anchoring them to our District. The School Board determined that it is not a core function of the School System to develop a program of this sort. Therefore, it is entrusted to this committee to carry out its mission. Ms. Greer reviewed the mission of the committee which is stated in agenda item B-8 dated November 13, 2006.

3. SELECTION OF CHAIR, OPERATION OF COMMITTEE

Mr. Luis Garcia of the School Board Attorney's office reviewed the guidelines for the operation of the Committee and opened nominations for the Chair and Vice Chair of the Committee. Mr. Buster Castiglia and Ms. Zully Ruiz were selected as Chair and Vice Chair respectively.

4. ANALYZING THE NEED

The committee recognized that formulating an effective survey was crucial in accurately analyzing the housing need of our teachers. A sub-committee consisting of Mr. Buster Castiglia, Ms. Sara Herald, Mr Erik Fresen and Mr. Artie Leichner was formed to develop this survey.
