The School Board of Miami-Dade County, Florida announced on October 17, 2007, its intention to amend School Board Rule 6Gx13- 5D-1.091, Student Services PK-Adult, at its meeting of November 20, 2007, to comply with changes reflecting actions by the School Board in its reorganization of the Division of Student Services, as well as updated guidelines provided by the Florida Department of Education.

The document, *Comprehensive Student Services Program PK-Adult*, which is incorporated by reference and made part of this rule, is proposed to be repealed to promulgate a new document.

The proposed new document, *Comprehensive Student Services Program PK-Adult*, includes standards and benchmarks tied to the educational development, personal/social, career/community awareness and health and wellness domains of our students. The benefits of the student services program are to provide students with opportunities that will assist them to graduate with the necessary competencies to make self-directed, realistic, responsible decisions and to be successful contributors to society.

The *Comprehensive Student Services Program PK-Adult* is a guide used by student services personnel at the school site to deliver an integrated program that includes the development of competencies in the following areas:

- Decision making skills;
- Career and postsecondary planning;
- Effectively working with others;
- Educational and vocational development;
- Skills that promote lifelong learning;

- Social adjustment; and
- Responsibility for personal behavior.

Changes have been made to incorporate current District procedures and enter new language, as appropriate.

Highlights of amendments to the *Comprehensive Student Services Program PK-Adult* include:

- Inclusion of Standards and Benchmarks to identify the knowledge and skills all student will acquire tied to educational development, personal/social, career/community awareness and health and wellness domains of our students; and
- Implementation of Health Connect in Our Schools (HCiOS) and the inclusion of Physical Education and Health Literacy into the Comprehensive Student Services Program PK-Adult to reflect reorganization changes in the Division of Student Services.

The Notice of Intended Action was published in the *Miami Daily Business Review* on October 22, 2007, posted in various places for public information, and mailed to various organizations representing persons affected by the rule and to individuals requesting notification.

The time to request a hearing or protest the adoption of this rule has elapsed.

Copies of the proposed repealed document, *Comprehensive Student Services Program PK-Adult*, which is incorporated by reference and is a part of School Board rule 6Gx13-5D-1.091, and the new document, *Comprehensive Student Services Program PK-Adult*, to be incorporated by reference and made part of the rule, will be forwarded to the School Board Members under separate cover and will be available for inspection by the public in the Office of Board Recording Secretary, Room 924, and the Citizen Information Center, Room 158, 1450 N.E. Second Avenue, Miami, Florida 33132.

In accordance with the provisions of the Administrative Procedure Act, this amended rule is presented to The School Board of Miami-Dade County, Florida, for adoption and authorization to file the rule in the official records of The School Board of Miami-Dade County, Florida.

Attached are the Notice of Intended Action and the proposed amended rule. Changes from the current rule are indicated by underscoring words to be added and ~~striking through~~ words to be deleted.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

1. adopt amended School Board Rule 6Gx13- 5D-1.091, Student Services PK-Adult;
2. repeal the document, *Comprehensive Student Services Program PK-Adult*, which is incorporated by reference and is a part of this rule; and
3. promulgate new document, *Comprehensive Student Service Program PK-Adult* which will be incorporated by reference and made part of this rule, and authorize the Superintendent to file the rule with The School Board of Miami-Dade County, Florida, to be effective November 20, 2007.

NOTICE OF INTENDED ACTION

THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, announced on October 17, 2007, its intention to amend Board Rule 6Gx13- 5D-1.091, Student Services PK-Adult, at its meeting of November 20, 2007.

PURPOSE AND EFFECT: The recommended amendment to this rule is the result of actions by the School Board in its reorganization of the Division of Student Services. In addition, the document, *Comprehensive Student Services Program PK-Adult*, incorporated by reference and made part of this rule, is proposed to be repealed in order to propose the new document, *Comprehensive Student Services Program PK-Adult*, to be incorporated by reference and made part of this rule, to set standards and benchmarks for the educational, personal/social, career/community, and health and wellness domains of our students. In addition, recommendations from various stakeholder groups have been incorporated into this rule.

SUMMARY: The rule establishes the restructuring of the Comprehensive Student Services Program PK-Adult to incorporate standards and benchmarks for the educational, personal/social, career/community, and health and wellness domains.

ANY PERSON WHO DECIDES TO APPEAL THE DECISION made by The School Board of Miami-Dade County, Florida, with respect to this action will need to ensure the preparation of a verbatim record of the proceedings, including the testimony and evidence upon which the appeal is based.
