The purpose of this bid, opened on October 9, 2007, is to establish a contract, at firm unit prices, for the relocation, assembly, installation and setup, of new and existing office and classroom furniture, and specified fixtures and equipment, for Capital Improvement Projects. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Ten (10) vendors responded to this advertised solicitation.

This contract will be awarded to the five (5) lowest bidders and will establish a list of approved vendors. As the need arises for services, these vendors will be contacted to submit a competitive quotation for specific scopes of work. The recommendation below reflects a partial award. Additional vendors are currently being evaluated and a recommendation for award will be submitted at a future Board meeting.
