SUBJECT: REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR MOUNT HERMON COMMUNITY EDUCATIONAL CORPORATION, ON BEHALF OF RICHARD ALLEN LEADERSHIP ACADEMY, AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL AGREEMENT FOR A TERM OF FIVE YEARS

As established in School Board Rule 6Gx13- 6A-1.471, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) has received charter school applications from individuals and/or organizations in the community.

On November 27, 2007, M-DCPS Charter School District Review Committee met to review the application for Richard Allen Leadership Academy and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The single-gender charter school proposes to serve a maximum of 250 male students in grades kindergarten through five, with a maximum of 134 male students in its first year of operation, commencing with the 2008-2009 school year and continuing throughout the term of the contract, which ends on June 30, 2013, and concludes in the 2012-2013 school year.

Following is the Founding Board for the charter school: Mr. Leon Bland, Co-Owner, Royal Funeral Services; Mrs. Frances Young, Adjunct Professor, Miami Dade College; and Rev. Dr. Carlton Waterhouse, Assistant Professor of Law, Florida International University.

The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

1. approve the application for Mount Hermon Community Educational Corporation, on behalf of Richard Allen Leadership Academy; and
2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of five years, commencing with the 2008-2009 school year and continuing throughout the term of the contract, which ends on June 30, 2013, and concludes in the 2012-2013 school year, which reflects the contents of the application as approved by the School Board.
