As established in School Board Rule 6Gx13- <u>6A-1.471</u>, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) has received charter school applications from individuals and/or organizations in the community.

On November 9, 2007, M-DCPS Charter School District Review Committee met to review the application for Somerset Academy Charter Middle School (Homestead) and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 900 students in grades six through eight, with a maximum of 900 students in its first year of operation, commencing with the 2008-2009 school year and continuing throughout the term of the contract, which ends on June 30, 2018, and concludes in the 2017-2018 school year.

Marin, Director of Project Management, San Antonio City Employees Federal Credit Union.

The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.
