                  AUTHORIZATION TO NEGOTIATE A CONTRACTUAL  
                  AGREEMENT FOR A TERM OF TEN YEARS**

As established in School Board Rule 6Gx13- 6A-1.471, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) has received charter school applications from individuals and/or organizations in the community.

On November 9, 2007, M-DCPS Charter School District Review Committee met to review the application for Archimedean Upper Conservatory and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 320 students in grades nine through twelve, with a maximum of 80 students in its first year of operation, commencing with the 2008-2009 school year and continuing throughout the term of the contract, which ends on June 30, 2018, and concludes in the 2017-2018 school year.

Following is the Governing Board for the charter school: Dr. George Kafkoulis, Associate Professor of Florida International University; Mr. Aleco Haralambides, Attorney; Dr. Christodoulos Christodoulou, Staff Mechanical Engineer, Beckman Coulter Corporation; Mr. A. Platon Alexandrakis, Attorney, Assurant Solutions; and Dr. Kyriakos Pefkaros, Former Assistant Professor/Head of the Coronary Unit, Jackson Memorial.

The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida:

1. approve the application for Archimedean Academy, Inc., on behalf of Archimedean Upper Conservatory; and
2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of ten years, commencing with the 2008-2009 school year and continuing throughout the term of the contract, which ends on June 30, 2018, and concludes in the 2017-2018 school year, which reflects the contents of the application as approved by the School Board.
