SUBJECT: REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR MARTIN MEMORIAL SOCIAL SERVICES, INC., ON BEHALF OF DR. JOHN C. PITTMAN CHARTER SCHOOL, AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL AGREEMENT FOR A TERM OF FIVE YEARS

As established in School Board Rule 6Gx13- 6A-1.471, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) has received charter school applications from individuals and/or organizations in the community.

On November 27, 2007, M-DCPS Charter School District Review Committee met to review the application for Dr. John C. Pittman Charter School and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 500 students in grades kindergarten through five, with a maximum of 116 students in its first year of operation, commencing with the 2008-2009 school year and continuing throughout the term of the contract, which ends on June 30, 2013, and concludes in the 2012-2013 school year.

Following is the Founding Board for the charter school: Ms. Ernestine Smith Davis, Social Services Supervisor, Miami-Dade County Department of Human Services; Mr. Anthony LaMar Brown, Administrative Officer, Florida International University; Ms. Frieda Lynette Brown, Vice-President, Total Bank; Dr. John C. Pittman, Associate Professor, Barry University; Reverend Anthony Reed, Pastor, Martin Memorial African Methodist Episcopal Church, Inc.; and Mr. Henry Lee Givens, Capital Inventory Specialist, Miami-Dade Water & Sewer Department.

The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

1. approve the application for Martin Memorial Social Services, Inc., on behalf of Dr. John C. Pittman Charter School; and
2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of five years, commencing with the 2008-2009 school year and continuing throughout the term of the contract, which ends on June 30, 2013, and concludes in the 2012-2013 school year, which reflects the contents of the application as approved by the School Board.
