
The District is presently completing the construction of State School "P-1", located at 11250 NW 86 Street. The project requires the improvement of the portion of NW 86 Street located adjacent to the school. As a result, Miami-Dade County (County) has requested that the District dedicate certain Board-owned land for use as public right-ofway.

The land to be dedicated to the County totals approximately 31,915 square feet, or .73 acres, more or less, and is more fully described in Exhibit "A", attached hereto.

The right-of-way document will be reviewed by the School Board Attorney's Office and the Office of Risk and Benefits Management prior to execution. The Principal, Regional Center III Superintendent and the Office of School Facilities concur with the proposed right-of-way dedication.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Chair and Secretary to execute the necessary documents to dedicate land to Miami-Dade County for right-of-way purposes adjacent to State School "P-1".
