A graduate of Coral Gables Senior High School and Florida A & M University, Coach Rolle began his teaching career in 1985 at Miami Edison Senior High School where he also began coaching football. Teaching and coaching for more than two decades, Coach Rolle has been a mentor to many young men and women in our schools and community.

A former professional football player, Coach Rolle has used his time and talent to teach students the principles of integrity, respect, responsibility, fairness, and honesty through the sport of football. Coach Rolle has distinguished himself in the community as a role model and mentor through his work with young people. He has received numerous honors, including the NFL Miami Dolphins Coach of the Year in 1998 and 2004, 2000 Educator of the Year as selected by Zeta Phi Beta Sorority, and the Florida High School Athletic Association Class 6A Coach of the Year in 1998 and 2007. In 2003, Coach Rolle was inducted to the Florida A & M University Sports Hall of Fame. As a head football coach, he has led teams to three high school state championships: Miami Northwestern Senior High School in 1998 and 2007 and Miami Killian Senior High School in 2004.

Coach Rolle's passion for football and love for children are evidenced by his community service and personal philosophy, which says, "If I can help the children, then my living is not in vain."
