The purpose of this bid, opened on September 25, 2007, is to purchase, at firm unit prices, quantities, as may be required, of fence-line maintenance, lot maintenance, tractor mowing, mechanical clearing and collection, removal and proper disposal of bulk trash and debris, as needed, for Miami-Dade County Public Schools (M-DCPS) facilities, sites and locations. This is a term bid which states that the Board may purchase quantities as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Nine (9) vendors responded to this advertised solicitation. This is an award to a primary and an alternate vendor.
