The purpose of this bid, opened on February 12, 2008, is to purchase and deliver, at a firm unit price, quantities, as may be required, of smoothies, frozen yogurt, milkshakes and frozen treats, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Two (2) vendors responded to this advertised solicitation.

No bid was received for Item 3 - Milkshake, low-fat, assorted flavors. The recommendation reflects that this item be rejected. Competitive prices will be solicited for this item, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
