This contract was awarded by the Board on August 1, 2007, to purchase, at firm unit prices, quantities, as may be required, of charter-bus services, in and out of county, for various schools and departments.

Various bus capacities (47/50, 51/55, and 56/61) were awarded to Miami Tours Limousines, Inc., of Miami, Florida. During the term of the contract, the vendor failed to provide a renewal of certificate of insurance form, as required by the terms of the contract and was, subsequently, removed from the approved charter-bus list. The vendor was afforded an opportunity to cure, and did not comply with repeated requests. It is, therefore, recommended that Miami Tours Limousines, Inc. be considered in default and that the award of these items be terminated.
