The 12th Annual International "Walk Our Children to School Day," planned for Wednesday, October 8, 2008, promotes pedestrian safety education and awareness for the benefit of students who walk to school every day. The nationwide observance is designed to promote awareness about pedestrian safety among students, parents, and schools. The program increases the awareness of safe walking skills, safe routes to school for students and parents as well as walking as an exercise that promotes good health and physical fitness. In addition, it helps the environment by reducing school-related traffic and pollution and reinforces the importance of reducing traffic speed and obeying the school speed zone limits.

The Metropolitan Planning Organization (MPO) and the Bicycle Pedestrian Advisory Committee have endorsed "Walk Our Children to School Day", which is sponsored nationwide by the National SAFE KIDS Coalition. According to the MPO, 174 children under the age of 14 were injured and four children were killed in 2006, as a direct result of pedestrian accidents in Miami-Dade County. Sadly, these numbers represent an increase in injuries as compared to 2005.

In conjunction with this program, it is recommended that the "WalkSafe" pedestrian safety program curriculum be implemented to coincide with the "Walk Our Children to School Day" event. "WalkSafe" was developed and implemented by the Ryder Trauma Center at the University of Miami Miller School of Medicine/Jackson Memorial Medical Center to reduce pediatric pedestrian injuries and fatalities. Both programs are of no cost to the District. All School Board members, District staff, school administrators and teachers are encouraged to participate in these events.

There is no cost to the District.

WHEREAS, the international “Walk Our Children to School Day” program, which will be observed on October 8, 2008, increases the awareness of safe walking skills and safe routes to school for students and parents; and

WHEREAS, the program reinforces the importance of reducing traffic speed and obeying school speed zone limits; and

WHEREAS, “Walk Our Children to School Day” helps the environment by reducing school-related traffic and pollution; and

WHEREAS, the program promotes walking as an exercise for good health and physical fitness;
