The purpose of this bid, opened on April 22, 2008, is to purchase, at firm unit prices, quantities, as may be required, of custodial supplies, for Stores and Mail Distribution stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Twenty-five (25) vendors responded to this advertised solicitation.

Items 1 through 4, 8, 9, 11, 15 through 17, 19, 21 through 26, 28, 29 and 33 were awarded by the Board on June 18, 2008, for an estimated expenditure amount of \$312,679.38.

Identical prices were submitted on Item 27 – Bottle, spray, with trigger spray unit, by Ideal Supply, Inc., of Oakland Park, Florida, and Calico Industries, of Annapolis Junction, Maryland. The recommendation reflects the award of this tie low bid item to Ideal Supply, Inc., of Oakland Park, Florida (Florida vendor), pursuant to Board Rule 6Gx13- 3C-1.061 – Identical Prices – Priorities for Award.
