Since the start of the 2008 Hurricane season, several storms have devastated the Caribbean. In the aftermath of the most recent storm, Hurricane Ike, families and displaced communities are seeking immediate relief and resources. In Haiti alone, more than 300 lives have been lost and 82,000 more have been displaced.

The employees and students of Miami-Dade County Public Schools can make a significant impact to these devastated regions by supporting the relief efforts of local and national organizations. The Superintendent of Schools, administration, staff and students have an opportunity to join with others around the nation to demonstrate community service on a global level.

It is important for students to learn and understand that service extends beyond their local communities to other countries and regions. Participation in this relief effort will teach students the importance of global citizenship and agency-to-agency collaboration in providing support and assistance to those in need worldwide.

Principals should hold an emergency relief drive at their schools to collect non-perishable food items. Other items needed include first aid items and clothing.
