The purpose of this bid is to purchase and deliver, at firm unit prices, quantities, as may be required, of cafeteria supplies, for Stores and Mail Distribution stock. Eight (8) vendors responded to this advertised solicitation. This is an award to a primary and alternate vendor.

Identical prices were submitted on Item 18, 18" roll plastic wrap, by A.G.E. Paper Company, of Hialeah, Florida, and Lace Foodservice Corporation, of Miami, Florida.
