Subsequent to the award, Sam Ash Quikship Corp., of Tampa, Florida, advised Procurement Management Services of its inability to provide delivery of goods in accordance with the terms and conditions of the contract. Therefore, the recommendation reflects the termination of Sam Ash Quikship Corp. on Contract No. 054-GG08 and the loss of its eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 – Performance and Payment Security, Declining a Bid Award, and Bonding Company Qualifications.

Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 Bidding Process – Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
