**SUBJECT: REQUEST SCHOOL BOARD APPROVAL OF THE SECOND RENEWAL OF THE CHARTER SCHOOL CONTRACTUAL AGREEMENT WITH MIAMI COMMUNITY CHARTER SCHOOL, INC., ON BEHALF OF MIAMI COMMUNITY CHARTER SCHOOL**

Section 1002.33(7)17(b)(1), Florida Statute, Charter Schools, stipulates that a charter school contractual agreement may be renewed provided that a program review demonstrates that the school has met the criteria in its charter contract and that the grounds for non-renewal have not been documented.

The initial charter school contractual agreement for Miami Community Charter School, Inc., on behalf of Miami Community Charter School (Miami Community), was approved by The School Board of Miami-Dade County, Florida (The School Board), on February 11, 2004, for a term of five years, commencing with the 2004-2005 school year, and expiring on June 30, 2009. Subsequent actions were granted by The School Board to amend the location and grade levels and to renew the contract for a limited term of one year commencing with the 2009-2010 school year, and ending June 30, 2010. Miami Community is located at 101 S. Redland Road, Florida City, Florida 33034, and serves approximately 394 students in kindergarten through grade five.

Miami Community is eligible to be graded under Florida's System of School Improvement and Accountability. Its academic performance for the term of its charter contract is as follows:

Miami Community's financial statements for the fiscal year ended June 30, 2009, show the school to be in a very strong financial position, and the external auditor found no inaccuracies, irregularities and/or violations of laws, regulations or contractual provisions. Additionally, the school has not met any of the conditions described in Section 218.503(1), Florida Statutes related to Financial Emergency.

The Charter School Contract Review Committee (CRC) met on December 4, 2009, and by a unanimous vote made a recommendation for approval of the second renewal of the charter school contractual agreement with Miami Community Charter School, Inc., on behalf of Miami Community Charter School.

Copies of the renewal to the charter school contractual agreement will be transmitted to the School Board Members under separate cover and will be available for inspection by the public in the Office of Board Recording Secretary, Room 924, and in the Citizen Information Center, Room 158, 1450 N.E. Second Avenue, Miami, Florida 33132.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, approve the second renewal contract with Miami Community Charter School, Inc., on behalf of Miami Community Charter School, for a term of five years, commencing with the 2010-2011 school year, and ending on June 30, 2015.
