The purpose of this bid is to purchase, at firm unit prices, quantities, as may be required, of custodial floor-care products, for Stores and Mail Distribution stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Fifteen (15) vendors responded to this advertised solicitation.

This bid includes a new product, which is an environmentally-friendly product, approved by the Florida School Plant Management Association, that will be used in all Miami-Dade County Public Schools, which may result in a cost savings due to the reduced number of applications and labor costs.
