This contract has been designated as an open competitive contract for pre-qualified competitive bidders. It also includes Minority Business Enterprise subcontracting assistance levels.

The Project Architect's final construction cost estimate for this project is \$23,911,197 and the independent cost estimate is \$20,572,164. The construction budget for this project is \$ 22,500,000. The Base Bid of the low bidder is 9.9% under the budget.

Twenty-six pre-qualified contractors were notified of this project and 9 firms picked up plans and specifications.

Advertised bids received and opened on June 3, 2010 by The School Board of Miami-Dade County, Florida were tabulated and analyzed as follows:
