The Superintendent of Schools has recommended that these students be expelled from the regular and adult programs of Miami-Dade County Public Schools (M-DCPS) and assigned to alternative schools/programs for the maximum time permitted under law, which is the 2009-2010 school year, 2010 summer session, and the 2010-2011 school year.

The parents have been duly notified of the recommendations for expulsion and were given an opportunity for a conference with staff and were advised of their right to a hearing before an impartial hearing examiner. The parents chose not to request a hearing.

10. provide educational services in alternative school/programs during the term of the expulsion; and
11. following the term of the expulsion, permit the students to be returned to regular school programs in Miami-Dade County Public Schools, if approved by District/School Operations.
