ENGLISH LITERACY/CIVICS EDUCATION**

Authorization is requested to accept a grant award from the Florida Department of Education (FLDOE) in the approximate amount of \$2,182,366, to fund the Adult Education – English Literacy/Civics Education program, for the grant period of July 1, 2010, through June 30, 2011. Under the Adult Education and Family Literacy Act, the FLDOE has awarded the District a grant award to support projects that demonstrate best and effective research-based practices in providing and increasing access to English literacy programs and linked to civics education. Under these initiatives, the FLDOE requires the District to form collaborative partnerships with community partners and provide a variety of services to meet the special needs of the learners. The grant award targets specific populations such as non-native English speakers, migrants, English language adult learners, and immigrant parents of school-aged children. The Division of Bilingual Education and World Languages manage this performance-based program.

The 2009-10 funding for this program was \$2,182,366. No matching funds are required as a condition to receive the grant funding. Grant funds will be used for full-time and part-time salaries, contracted services, travel, computer hardware and software, materials and supplies, and indirect costs.

Official notification of this grant award is expected on or before August 1, 2010. Reimbursement of grant-related expenditures is authorized effective July 1, 2010.

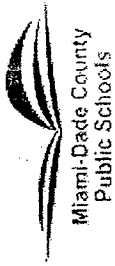
**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept a grant award from the Florida Department of Education (FLDOE) for funding under the Adult Education and Family Literacy Act (AEFLA), in the approximate amount of \$2,182,366, for the grant period July 1, 2010, through June 30, 2011;
2. extend this program and contractual agreements as authorized through official notification from the granting agency, in order to complete the goals of the program;
3. retain funds from the grant in the amount not to exceed the annually negotiated indirect cost rate, as allowed and approved by FLDOE.
4. direct Financial Services to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board; and
5. authorize travel out-of-state as required by the grant parameters.
