**SUBJECT: CURRENT CENSUS 2010 PARTICIPATION RESULTS**

**LINK TO STRATEGIC FRAMEWORK: STUDENT, PARENT AND COMMUNITY ENGAGEMENT**

The National Association of Latino and Elected Officials (NALEO), the premier partner of the Census 2010 according to a nationwide survey of Latinos by the Pew Hispanic Center, is proud to announce a 69% participation rate of the Census 2010 from Miami-Dade County. This is an increase of a full 2% from Census 2000. This increase is due to the hard work of the Census 2010 partners in collaboration with Miami-Dade County Public Schools, Miami-Dade County and numerous municipalities. Enumeration is still taking place and will continue until July 10, 2010.

Although America's participation rate stayed constant at 72%, Florida's Census 2010 participation rate of 72% was 3 percentage points higher than the Census 2000 participation rate. The final demographics will be published for the public in January 2011. The final numbers will be seen first by President Barack Obama by December 31, 2010. This data will be used for congressional apportionment and redistricting. Some states will likely gain (or lose) seats in the U.S. House of Representatives based on the 2010 Census count. By March 31, 2011, the Census Bureau will release more detailed data to help states redraw congressional, state, and local legislative district boundaries, in a process called "redistricting."

The U.S. Census counts every resident in the United States, and is required by the Constitution to take place every 10 years. The 2010 Census will help communities receive more than \$400 billion in federal funds each year for things like: hospitals, job training centers, schools, senior centers, bridges, tunnels and other public works projects.
