Background

On July 11, 2007, the Board commissioned Adviron Environmental Systems, Inc. (AES), to provide Environmental Consulting and Testing Services (EC&TS) for a four-year term, with the second, third and fourth years at the option of the Board. AES provides EC&TS services for facilities in Regions 2, 4 & 6.

In a separate item, on July 11, 2007, the Board commissioned EE&G/EMSL Joint Venture (EE&G/EMSL), to provide Environmental Consulting and Testing Services (EC&TS) for a four-year term, with the second, third and fourth years at the option of the Board. EE&G/EMSL provides EC&TS services for facilities in Regions 1, 3 & 5.

Scope of Services

Services include, but are not limited to, field sampling/testing and laboratory analysis, environmental inspections and investigations, environmental reports and recommendations, and other related professional consulting services to assist MDCPS with mitigation of environmental issues. These professional services shall address various environmental disciplines including, but not limited to, asbestos, lead, mold, biocontaminants, and other Indoor Air Quality concerns.

To date, for the third-year option of the Agreements, AES has been paid \$91,147, and EE&G/EMSL, \$85,895.

Reduction of Fees and Elimination of CPI Adjustment

Due to current economic conditions, staff requested, and both firms have agreed to, approximately 10% reduction of most fees for this fourth-year option. The revised fee Schedules are attached as Exhibit "A". If authorized by the Board, the effective date of the 4th-year option with reduced fees is July 11, 2010; the Agreements will expire on July 10, 2011.

In addition, the original Agreements provided for an annual CPI adjustment. Both firms have agreed to eliminate this provision for the 4th-year option.

Performance Evaluation

The most recent average performance evaluation scores issued by staff to the firms were for the period ending June 21, 2010. Based on a performance scale of 1-5 (low to high), AES received 4.66, and EE&G/EMSL, 4.71.

Based on the information above, staff recommends authorization to exercise the fourthyear option of the Environmental Consulting and Testing Services Agreements.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent, or his designee, to exercise the fourth-year option of the Agreements with Adviron Environmental Systems, Inc., and EE&G/EMSL, Joint Venture, to provide Environmental Consulting and Testing Services, as follows:

- 1) with reductions of fees as set out in Exhibit "A";
- 2) amend the Agreement to eliminate the CPI adjustment; and
- 3) all other terms and conditions of the Agreement remain the same.
