Filer and Norland middle schools, and Miami Senior High School. Since 2006, Dr. Domínguez has served as administrative director in District/School Operations where she is responsible for overseeing the Attendance Boundary Committee and the Division of Athletics, Activities, and Accreditation.

Dr. Domínguez earned a Bachelor of Arts degree from Marygrove College, and a Master of Science degree and a Doctorate in Education from Nova Southeastern University. A dedicated school administrator, Dr. Domínguez received The National Association of Hispanic Public Administrators Excellence in Education Award in 2002 and she was the M-DCPS Principal of the Year runner-up that same year. She has been a member of several professional organizations, including, the Dade Association of School Administrators and the Florida Association of School Administrators. Under her leadership, MAST Academy was named a U.S. Department of Education (DOE) New American High Schools Showcase Site in 1999 and the school received the U.S. DOE Blue Ribbon School of Excellence Award in 2006.
