The Mission provides food, clothing and shelter, and recovery programs for those seeking to change their lives in positive ways. To meet the needs and concerns of the community's most vulnerable residents, the Mission operates several centers to assist children and families, including the Center for Men, the Center for Women and Children, the Jeffrey A. Tew Education Center, and the Community Activity Center.

The Center for Men offers a comprehensive, year-long residential Regeneration Program while the Center for Women and Children serves as a haven, providing homeless women and children emergency overnight shelter as well as a long-term recovery program. The Jeffrey A. Tew Education Center offers state-of-the-art education and computer technology training for those who want to improve their academic skills and prepare for re-entry into the job market. The Mission's Community Activity Center is designed with the needs of today's youth. The 18,000 square foot center hosts a variety of programs from athletics to academics to summer camp programs. Serving 180 children, the Community Activity Center provides nearly 2,000 hours of after-school tutoring. Children also benefit from outings to city parks, public libraries, and professional athletic events.
