On Friday, March 4, 2011, President Barack Obama visited Miami Central Senior High School with U.S. Secretary of Education Arne Duncan, and former Florida Governor Jeb Bush. Miami Central Senior High was chosen for the visit because of its improved school performance. Miami Central Senior High School has seen dramatic results, including a 40-point increase in writing achievement, a 60-point increase in math, and almost doubling its graduation rate.

During the President's remarks to an audience of students, faculty, and community members he announced that the White House had designated March 2011 as "Education Month," and that it was because of the outstanding progress toward improvement made by the staff and students of Miami Central Senior High School that it was selected to kick-off Education Month. During the month of March, the President and U.S. Secretary of Education Arne Duncan will travel across the country to speak to parents, students and educators about improving education through investments that are focused on responsibility, reform, and results.

The President has cited outstanding teachers and principals, a common mission, and a culture of high expectations as "what it takes to turn a school around." Miami-Dade County Public Schools is proud to have an abundance of each of these ingredients, and therefore, our schools are poised to continue the improvement that has brought Miami-Central Senior High and our entire District this historic recognition.
