State Representative Jose Felix Diaz has filed House Bill 37 seeking to enhance the \ penalties against caregivers of minor children who willfully or by culpable fail to report a child missing within a 48-hour period. Senator Anitere Flores has filed the same legislation in the Senate.

The security and safety of our students and all children is absolutely fundamental. Supporting this common sense bill sends a strong message in favor of protecting the lives of young, defenseless children. Holding caregivers accountable for failure to report a missing child to the proper authorities will assist law enforcement officials in the investigation and resolution of cases involving missing children.

The Miami-Dade County Public Schools should support any and all reasonable measures designed to protect children from harm by strengthening the criminal sanctions against those who harm children through their actions, inactions and - Added omissions.
