The Miami HEAT seeks to continue to operate an after-school academic program which will assist children by providing tutoring and enrichment in reading and mathematics. Using the popularity of professional sports, *The Miami HEAT* will continue to utilize the HEAT name to motivate students to stay in the classroom and, just as in sports, encourage practicing the fundamentals of learning. The program has been in operation since 1999 at Paul Laurence Dunbar Elementary School and in the past few years has expanded to include Jesse J. Mccrary, Jr. and Riverside Elementary Schools at the request of the Miami HEAT.

The Miami HEAT will make a donation, in an amount not to exceed \$250,000, to Miami-Dade County Public Schools to operate *The HEAT Academy*. The program at Riverside Elementary School will operate five days a week for two hours a day; the program at Paul Laurence Dunbar Elementary School will operate five days a week for one and a half hours per day; and the program at Jesse J. Mccrary, Jr. Elementary School will operate four days a week for one and a half hours per day. The program is free for selected students at each school. The students are chosen through a random lottery. Funds received for the after-school academic program will provide: salaries for teachers and teacher aides, curriculum materials, supplies, and security and custodial services at each school.

The HEAT Academy will offer additional enhancements, such as motivational speakers, incentives, and appreciation events. Parental involvement opportunities will be implemented and encouraged. All procedures, as outlined in the Community Schools Procedures Manual, will be followed in implementing the program.

There are no additional costs associated with this program since administration is provided by existing community school funds.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida, authorize the Superintendent to accept a donation, in an amount not to exceed \$250,000, from *The Miami HEAT* to continue operating an after-school academic program, entitled, *The HEAT Academy*, at Paul Laurence Dunbar, Jesse J. Mccrary, Jr., and Riverside Elementary Schools during the 2011-2012 school year.
