At 8:46 a.m., on September 11, 2001, hijacked American Airlines Flight 11 crashed into the upper portion of the North Tower of the World Trade Center in New York City, New York. At 9:03 a.m., hijacked United Airlines Flight 175 crashed into the South Tower of the World Trade Center. Hijacked American Airlines Flight 77 hit the west wall of The Pentagon at 9:37 a.m. and the impact caused immediate and catastrophic damage. At approximately 10:00 a.m., the passengers and crew of hijacked United Airlines Flight 93 acted heroically to retake control of the airplane and thwart the taking of additional American lives by crashing the airliner in Shanksville, Pennsylvania, and, in doing so, gave their lives to save countless others.

Nearly 3,000 innocent civilians were killed in the attacks, in addition to 343 firefighters and 60 police officers, all together constituting the largest loss of life in a single day by emergency response workers in United States history. Countless fire departments, police departments, first responders, governmental officials, workers, emergency medical personnel, and volunteers responded immediately and heroically.

Today, 10 years later, the people of the United States and people around the world continue to mourn the tremendous loss of innocent life on that day, and thousands of men and women in the United States Armed Forces remain in harm's way defending the rights of Americans to live in a free and just society. As we observe the 10th anniversary of this tragic day, our thoughts are with the victims of the attacks of September 11, 2001, and their families.

The United States Senate Resolution 237 has called for a national moment of remembrance on Sunday, September 11, 2011, at 1 p.m. To further commemorate the anniversary of September 11, 2001, Miami-Dade County Public Schools is having a program on September 9, 2011, at 10:30 a. m., which will pay tribute to the heroes of that fateful day through the talents of our students.

WHEREAS, countless fire departments, police departments, first responders, governmental officials, workers, emergency medical personnel, and volunteers responded immediately and heroically; and
