A well-rounded student who also excelled in athletics, Dr. Woodard began his athletic career as a football player for three years at FAMU, where he won a Black National Championship, three Southern Intercollegiate Athletic Conference titles and was selected All-Conference and All-American Tackle-Honorable Mention in 1951. Dr. Woodard enlisted in the United States Army after graduating from FAMU.

In 1955, Dr. Woodard served as head coach of football, basketball, baseball, and track at Tivoli High School in DeFuniak Springs, Florida. His many successes at the school led him to achieve Coach of the Year in 1962-63. Dr. Woodard's former students from Tivoli High School are now successful teachers, doctors, attorneys, and judges.

In 1968, Dr. Woodard moved to Miami, where he served as assistant football coach and athletic director at Miami Central Senior High School. He earned a master's degree and doctorate in education administration and became assistant principal of Miami Edison Senior High School, and later, principal of Miami Douglas MacArthur High School-North, until his retirement in 1991.

Dr. Woodard is recognized as a strong, positive role model for young people. His caring attitude and leadership abilities have granted him induction into the FAMU Sports Hall of Fame and as a Distinguished Alumnus in Athletics for the university. Active in the community, he has successfully fulfilled membership and leadership roles in several community and national organizations, including the FAMU alumni association. His civic involvement has led to his numerous recognitions. He has been a board member of the Miami-Dade County Office of Community Development, former president of the Model Cities Optimist Club, director of Civitan of North Miami, as well as a member of the King of Clubs of Greater Miami, the National Alliance of Black School Educators and the Miami Alliance of Black School Educators.
