Designed to ensure that at-risk youth have access to an arts learning experience, AileyCamp Miami is a six-week full-scholarship program providing free transportation, food, and camp uniforms to 100 middle school students of Miami-Dade County Public Schools (M-DCPS). The program is designed for students with no formal dance training who may be experiencing academic, social, and domestic challenges. AileyCamp Miami seeks to foster personal development using dance as a vehicle for developing self-esteem, self-discipline, creative expression, and critical thinking skills.

One of the tenets of AileyCamp Miami is the belief that the arts are a means to achieving personal and educational goals. AileyCamp Miami's curriculum offers dance technique classes in ballet, Horton-based modern dance, jazz, and West African dance. The students also participate in personal development and creative communication classes that explore peer pressure, conflict resolution, nutrition, career development, goal-setting, and self-image.
