Established in 2002, The Fairchild Challenge has grown from 1,400 participants to more than 100,000 South Florida students and teachers. Specifically, during the 2010-2011 academic year, more than 80,000 participants were from Miami-Dade County Public Schools.

The goals of The Fairchild Challenge are for all students to recognize their role as environmental stewards and to increase the percentage of students pursuing advanced degrees in the sciences and STEM (science, technology, engineering, and math) careers. Students and teachers take part in friendly competitions during the school year to accrue points to win The Fairchild Challenge Award. Through the program, students engage in research, debate, the visual and performing arts, fashion design, creative writing, culinary arts, engineering, and habitat restoration; explore careers in science, creative thinking, and problem solve environmental issues. By participating in The Fairchild Challenge, students learn to appreciate nature and the importance of biodiversity and conservation, develop critical-thinking skills, and become actively engaged citizens and lifelong learners.
