SCHOOL DISTRICT LEADERSHIP

On November 18, 1994, Federal District Court Judge Lenore Nesbitt entered an Order approving the nine (9) single-member districts for the School Board of Miami-Dade County, Florida. In that Order, the Court established a mandate that the School Board re-designate the boundaries of board member residence areas after each decennial census to balance the populations within those boundaries to reflect the population changes indicated by the U.S. Decennial Census. In accordance with § 1001.36, Florida Statutes, the School Board is required to, among other things, make changes "deemed necessary in the boundaries of any district school board member residence area at a meeting of the school board in odd-numbered years." However, the law also provides that "no change that would affect the residence qualifications of any incumbent member shall disqualify such incumbent member during the term for which he or she is elected."

The 2010 United States Decennial Census indicates an increase in population of Miami-Dade County, Florida, over the last ten years by approximately 10.8%, but this growth has not been evenly distributed across the County. The School Board must redraw the nine residence area boundaries to achieve board member residence areas that are reflective of the population changes that have occurred since the 2000 U.S. Census. Accordingly, the School Board is legally required to review, formulate and approve a redistricting plan and adopt a resolution setting forth the boundaries for that plan prior to the end of 2011.

Prior to the presentation of the final redistricting map and the proposed redrawn residence area boundaries, the School Board held two Board workshops on the plan on September 14, 2011, and November 1, 2011. The public was also invited to a town hall meeting to discuss the proposed redistricting plan and the legal requirements for the Board's adoption of such a plan on November 2, 2011. Since October 6, 2011, the School Board has maintained information regarding its redistricting process on the School Board's website at http://redistricting.dadeschools.net/. The redistricting plan and the proposed district member election boundaries do not impact or change existing school attendance boundaries.

REVISED

Consistent with the deliberations at the School Board's Innovation, Efficiency & Governmental Relations Committee meeting held on November 17, 2011, attached are two Resolutions for the Board's consideration: Resolution 11-129 and Resolution 11-129A (the alternate map containing District 8 boundaries as proposed by Board Member, Dr. Marta Pérez). Each Resolution presents separate and distinct Board member election districts. One of the two proposed Resolutions must be approved by the Board in order to adopt the proposed boundaries of its redistricting plan. The redistricting plan and the proposed boundaries have been found by both the Board's legal consultant and its cartographer to meet the principle of "one-person, one vote" and the requirements of Section 2 of the Voting Rights Act, 42 U.S.C. §1973. Based on demographic data for the County, the population of each of the proposed singlemember district is within a plus or minus five (5) percentage point deviation. Resolution 11-129 and its alternative, Resolution 11-129A, consist of the recommended redistricting plans to provide a nearly proportionate population for each Board member election district pursuant to the 1994 Federal Court mandate to reapportion said districts after each decennial census.

REVISED

Upon the Board's approval of the redistricting plan, pursuant to § 1001.36(3), Florida Statutes, the approved Resolution will be certified to the Clerk of the Circuit Court for filing, and copies will be transmitted to the Secretary of State and the Miami-Dade County Supervisor of Elections, and, published in the manner prescribed by law. The legal descriptions with references to the United States Census blocks and map depicting the re-designated boundaries are attached.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida:

- 1) Approve the redistricting plan for The School Board of Miami-Dade County, Florida, making the changes deemed necessary to the boundaries for the nine (9) single-member School Board residence areas; and
- 2) Pass and adopt:
 - a) Resolution No. 11-129, incorporating the boundary descriptions for the approved plan;

or

b) Resolution No. 11-129A, incorporating the boundary descriptions for the approved plan;

and

3) Authorize the filing by the School Board Attorney with the Clerk of the Circuit Court, upon certification by the appropriate licensed professional, of any amended legal descriptions in the adopted Resolution.

RESOLUTION 11-129

A RESOLUTION OF THE SCHOOL BOARD OF MIAMIDADE COUNTY, FLORIDA, REDISTRICTING SAID COUNTY INTO NINE SINGLE-MEMBER ELECTION DISTRICTS SO AS TO PLACE EACH OF SAID DISTRICTS IN EQUAL POPULATIONS AS NEARLY AS PRACTICABLE.

WHEREAS, on November 18, 1994, Federal District Court Judge Lenore Nesbitt entered an order approving the nine (9) single-member districts for the School Board of Miami-Dade County, Florida and set forth a mandate that the School Board reapportion its district after each decennial Census; and

WHEREAS, Section 1001.36(2), Florida Statutes (2011), provides that the School Board may make any change which it deems necessary to the boundaries of any district school board member residence area, provided that such changes shall be made in odd numbered years; and

WHEREAS, the present nine School Board member election districts, which were established to provide an equal number of people in each district, currently contain disproportionate populations.

NOW, THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA THAT:

The School District of Miami-Dade County, Florida, be and the same is hereby divided into nine, single-member School Board residence areas and numbered one through nine, inclusive, bounded, and described as follows:


